PERIOD OF HIRE:

The period of hire shall commence from the time that the vehicle is unlocked and made ready for transportation to the nominated site, and shall cease at the time that the hirer grants access to the North MRA staff for the purpose of locking the vehicle for return transport.

CANCELLATIONS:

All fees will be refunded in full if cancellation occurs more than two weeks prior to the scheduled hire. A 50% refund will be given if cancellation occurs in the week prior to the scheduled hire. If cancellation occurs after the vehicle is on site, or in transit, no refund will be given.

TRANSPORT:

Transport arrangements are the hirers' responsibility. The transport company/person must provide to North MRA a certificate of currency regarding their cover of insurance. The transport company/person must liaise with North MRA a minimum of five working days prior to stage pickup as to what connections for lights/brakes/couplings will be required for the prime mover.

SETUP/PACKUP:

A fee of \$150.00 applies to all stage hires. All setup/pack up to be carried out by MRA staff only.

ADDITIONAL INFORMATION:

The hirer will be charged for the cost of any repairs/fines etc incurred whilst in their possession of hiring the stage.
A verbal/pencil booking will not secure hire. All requests for hire must be on the official hire form.
North MRA reserves the right to re-let the stage if the bond is not paid in the stipulated time.
North MRA reserves the right to cancel the hire if full payment is not received at least two weeks prior to the hire commencement date.

SPECIFICATIONS:

Custom built mobile stage. Registration no. WV 0498
Step access each side and also stage door.
Internal lights and power points fitted for connection to external source.
Dimensions: 12 metres in length, 4.6 metres wide when opened up, 2.2 metres in height (from stage floor to ceiling when opened up). Vehicle weighs 11 tonne.

I acknowledge that the stage is offered for hire on the basis that I comply with the "Conditions of hire" (see separate document).
